Hi Diane-

No need to send a specimen. Unfortunately, it is curly-leafed pondweed. I don't see the turion, an overwintering bud that feels kind of woody, but the rounded tips, slightly serrated edges, flattened stem, and the reddish mid vein are clear indications that it is curly leafed pondweed. It is a little surprising to see the plant so late in the year, since it often dies out in mid July, but we do occasionally see some late stragglers.

Sorry to be the bearer of bad news....(thought the pictures are terrific).
