CONSTITUTION & BY-LAWS of the MANLE(Chilson)LAKE PROPRTY OWNERS ASSN. Organized September 13th, 1907 at Eagle Lake, N.Y.

(This Constitution & By-laws was unarmously adopted on August 21, 1908)

We, as proporty-owners on Engle Lake, Essex County, N.Y., desire hereby to organize ourselves, our associates and successors into an Association for the surposes and objects set forth as follows:- First---For the protection of the mutual interests and property of the members.

Second--For the re-stocking of Eagle Lake from the hatcheries. Third---For the regulation and control of a uniform water-level in Eagle Lake.

Fourth--For the prevention of the pollution of the waters in Eagle Lake.

Fifth --- For the protection of the spanning bods in Eagle Lake.

Sixth---For the maintainence of a fish-way dam at the cutlet of Eagle lake and the control of same to prevent the migration of fish in the apring-time.

Seventh- and For such other objects and purposes as may from time to time be determined upon by the members of the Association for protecting the mutual interests and property of the memners, and we do hereby adopt the following By&Laws and adopt as the name for this Association "the Ragle(Chilson)Lake Troperty-Owners' Association".

BY-LAWS.

Article I--- (Membership)

Section 1. Any person who may be the comer of either improved or unimproved land which borders or fronts on Eagle lake or who owns land directly adjacent or antiguous to any land bordering or fronting on Eagle Lake and who may be elected in a manner prescribed in these By-laws and agree to these By-laws and pay the requisite fees, due or assessments as prescribed in these By-laws, shall be known as a member of this Association

Article II --- (Fiscal Year of the Association)

Section 1. The fiscal year of this Association shall commence on Septon first and end on August thirty-first of each year.

Article III --- (Annual Meeting, Election of officers &c)

Section 1. The election of officers shall be held at the annual meeting of the Association to be convened at Eagle Lake in the month of August each tear.

Sections, All elections shall be held by secret ballott.

Section 3. The following officers shall be annually elected, namely, one President, one Vice President, one Secretary-Treasurer, (a combined office), an Advisory Committee to consist of three members, two of whom are to be elected and the third shall be the President, ex-officio, a Committee on Fisheries to consist of three members, two of whom are to be elected and the third shall be the President, ex-office.

Article IV--- (Duties of Officers)

Section t. When present, the president shall preside at all meetings, he shall be an ex-officio member of all committees. He may require any motion to be reduced to writing before taking a vote thereon and he shall state every motion, amendment or substitute before submitting either to a vote of the members He shall appoint annually from among the members, all committees, the members of which are not elected and shall have the appointive power of any and all committees that may be necessary. He shall exercise a general supervision over the affairs and business of the Association and preserve order during the meetings and shall have the power to call any member to order for disobedience and be authorized to impose

a fine. At the annual meeting he shall make a brief report or deliver an address on the progress, results attained and future prospects of the Association. All marrants authorized to be drawn on the Depository shall be a marrants authorized to be the Secretary-treasurer and he shall be a strings as set fort in Article VIII Sections 1 & 2.

Section 2.In the absence of the President, the Vice President shall set act as President and while so acting shall be vested with

the authority conferred upon the President. Section 3. The Secretary-Treasurer shall conduct and have charge of the correspondence of the Association and shall preserve all the original letters received by him and keep memoranda or copie of all letters written by himself. He shall been a true and faithful copy or record, in a book provided for that purpose, of all the proceedings of the meetings of the Association. including the reports of Committees & officers, and shall file and preserve these reports in suitable order. He shall as far as possible state, in the minutes of the meetings, the names of the members present. He shall receive and receipt for fees, dues, assessments and other moneys accruing to the Association and deposit same as directed in the Bylaws. He shall issue the calls of all the meetings of the Association and notify the officers, members and committees of their election or appointment. He shall notify the President then no funds are in the treasury or depository to the credit of the Association and no warrant shall be drawn on either the treasury or depository unless there is money on deposit sufficient to pay out. He shall be the custodian of the Association's books, records, documents, papers, seals funds, etc., etc. He shall solicit the members to pay their dues, fees, assessments, ac and report to the meeting of the Association the names of the delinquent members. The Secrety Treasurer shall be allowed such reasonable compensation for his services as may be fixed by a majority vote of the members, which shall be paid quarterly on a warrant countersigned. by the President. He shall, before entering upon the duties of his office, execute unto the Association a bond in the penal sum of (\$250.00) Two hundred & fifty Dollars with one

or more solvent sureties, conditional for the true and faith

his services as may be fixed by a majority vote of the members, which shall be paid quarterly on a warrant countersigned. by the President. He shall, before entering upon the duties of his office, execute unto the Association a bond in the penal sum of (\$350.00) Two hundred & fifty Dollars with one or more solvent sureties, conditional for the true and faith ful performance of all his duties as Secretary-Treasurer. which bond shall be subject to the approval of the Advisory Committee. All sums in his hands as treasurer. in excess of Two hundred Dollars (\$200.00) he shall deposit in the Association's Depositary as hereinafter named and such deposit shall operate as a release pro tanto from liability on his bond. He shall report, at the annual meeting, the state of his account, a classified statement of all receipts and a detailed list of all expenditures and disbursements incurred during the year. He shall keep all receipts and vouchers on file and draw no checks on the Depository unless the warrant are authorized to be drawn, by the Association or President.

He shall perform such other duties as the Association may from time to time require by resolution. At the expiration of his term of office or at any time, upon the request of the President, all moneys, funds, accounts, books, records,

documents, papers, vouchers etc., that may be in his possess ion, he shall deliver to his successor or upon demand to the Association. Section 4. The Ticonderoga National Sank of Ticonderoga. N.Y. is hereby designated and named as the Demositoryvof this Association. Said depository shall receive from the Sedretary-treasurer any money offered by him and furnish deposit book and state ment therein of each deposit. The depository shall pay out

of said deposits only warrents or checks drawn on it when signed by the President and counter-signed by the Secty-Tres Section 5. All officers shall hold over in office until their successors have been chosen and qualified.

Article V--- (Committees & their Duties)

- Section 1. The Advisory Committee shall consist of three(3) members to be elected as set forth in Article III Sect.3. Their duties shall be the examination of all books, securities at at such times as the President may direct, upon which examination they shall submit their report. Upon direction by the President they shall make such other investigations and reports as may be prescribed by the President. Two members present at a meeting of this committee shall constitute a quorum.
- Section 3. The Committee on Fisheries shall consist of three(3) menbors to be elecyted as set forth in Article III Sect.3. The members of this committee shell electy their own chairman & such officers as they deem nevessary from among their number. Their duties shall be confined to matters pertaining to the Forest, Fish & Game Laws of the State of New York and of the United States and under direction of the President they shall take full charge of matters of the Association appertaining to the protection of the forest. fish and game, the re-stocking of Fagle Lake from the hatcheries, the protection of the spawning beds, the maintainance & care of the fish-way dam and spillway at the utlet of Eagle Lake, the nevention of the pollution of the waters of Ragle lake and such other analogous matters as may, from time to time, be determined upon by the members of the Assaciation. Two mumbers present at a meeting shall constitute a quorum.

Section 3.No Committee shall incur any expense unless authorized by the President. The work of all Committees and such Committees as may be appointed hereafter shall be under direction of the President. All Committees shall hold over in office until their successors have been chosen and qualified.

Article VII--- (Rules of Order)

- Section 1.All reports of Committees & officers shall be submitted in writing and spread upon the minutes.
- Section 3. The meetings of the "ssociation small be conducted in accordance with the rules in Cushing's Manual as far as applicable and all construction of terms shall be construed and recognized as defined in Webster's Unabridged Dictionary.

Artigle VIII--- (Neetings)

- Section 1. The annual meeting of the Association shall be held at Eagle
 Lake in the month of August of each year, on that day when
 most of the property-owners are liable to be present. At this
 meeting the annual election of officers & Committees shall be
 be held.
 - Section 3. Special meetings shall be called by the Secty-Treas, whenever requested by the President or at the request of any five
 (5) members of the Association and whenever a special meeting
 is called, notice of said meeting shall be sent by mail to
 all the members & said meeting shall not be called within
 less than Five days from the date of notification. At any

meeting, a majority vote of the members present or represented by proxy shall decide a question, but a two-thirds (9/3) vote of the members present & represented shall be required to decide the removal from office of any officer or committee-man.

Article IX--- (Fees, Dues, Assessments)
Section 1. The membership fee shall be One Dollar (\$1.00) for each new membership.

Section 2. The dues of members shall be One Dollar(\$1.05) per annum, payable annually in advance on August, first.

Section 3. When the lack of funds in the hands of the Treasurer require it in order to carry out the purposes and objects for which this Association is formed, assessments not to exceed Ten Dollars (\$10.00) at any one levy, may be levied on each menber by the Secretary-Freasurer, by consent of the majority of the Advisory Committee, All assessments that when levied

I Sect. 1 of these Ry-Laws and unless the application shall be offered in writing, indersed by a member in good standing and be accompanied by the prescribed membership fee Section 2.All applicant shall be subject to being elected as a member

Section S.All applicant shall be subject to being elected as a member by a secret ballott to be held by the members and two negative votes registered against the applicant shall be equivalent to rejection in which case the membership fee accompanying the applicant on shall be returned to the applicant.

Section 3.Each applicant for membership shall be required to fill out and sign the blank form of application herewith prescribed:-

Address----Accompanying Fee \$----Article XII--- (Payment of Dues &c) Section 1.Any member who shall be delinquent for any indebtedness and who shall fail to pay such indebtedness within one menth of notification by the Secretary-Treasurer shall be, inso facto suspended from all the privileges of members of the Association until such indebtedness is paid, but this shall not be construed to limit the power of the Association to expel. No member's account for indebtedness shall exceed Five Dollars ((5.31). Article XIII -- (Suspension, Expulsion & Resignation)

Section 1. The penalty of suspension & expulsion shall not be inflicted except upon a vote of &wo-thirds (3/3) of the members present & represented at a meeting.

Section 2. Section 3.A member who has been suspended from the privileges of members or who has resigned his membership may be re-instated by a majority vote at a neeting upon having made payment of all arrograges.

Section 4.No member who shall have been expelled for misdememor, misconduct or for having brought reproach upon the Kasociation shall be eligible for re-instatement.

Section 6. All voting relative to the suspension or expulsion of a member must be cast by secret ballots

Article XIV-- (Complaints & Suggestions suggestions Section 1. Any member desiring to make complaints to the Association shall do so in writing over his signature addressed to the Secretary-Treasurer, who shall then refer such communication for investigation.

Article XV-- (Registry & Notices)

Section L.All members of the Association shall have their post-office address enrolled by the Secretary-Treasurer and shall notify him of any change of address.

Section G.Notice mailed to the address of any member as noted in the

Section 3.Notice mailed to the address of any member as noted in the members list of addresses shall be considered as properly sent and shall be held to have been received within five day after having been mailed.

Article XVI-- (Quorum)

Section 1.Not less than five (5) enrolled members shall constitute a quorum for the transaction of the business of the Associating Section 2.A quorum of Committees shall be as set forth in Art.V.Secial.

Article XVII--(Proxy Votes)

Section 1.Any member in good standing may delegate any other member in good standing, who shall present written credentials of the member he is to represent, but such credentials and proxies shall be governed by Art. X and shall only be honored and recognized for the designated meeting and for that meeting only, after having been validated by the President. Such vot shall the be binding on the member delegating said credential whether as an individual, as a firm or as a corporation.

Article XVIII---(Amendments to By-laws)
Section Q1.Any amendments, additions or alterations to these By-laws
will require a two-thirds (9/3) majority vote of the total
number of members enrolled who are in good standing.
