Will you help us save the life of Eagle Lake and get started on this program?

Another irritant to the members of the association is the camping at the boat launching site. There are no toilet facilities there. Remember many of us drink the lake water.

It really amazes me why this is tolerated when there are vacant campsites at Parade and other campsites. Don't the State Troopers see this on their rounds.

I tried to call you over the week-end I guess your a busy man. We own the little white house on the lake side of the road at the East end of the lake. My family will be there for the rest of the summer. If you pass by please stop in and say hello. We would love to discuss this in further detail with you.
