## 62nd Annual Meeting Sagle Lake Property Owners Association

14 members attended the 62nd Annual Meeting of the bagle Lake Property Owners Association, held at Crown Point Beach Saturday, Aug. 9, 1969 at 2:30 P. M. The list of those attending is appended to the minutes.

The minutes of the 61st Annual Meeting and of the Special Meeting of July 5, 1969 were read and approved.

The 1962 Tressurer's Report, showing a balance of \$672.77, was approved as presented, a copy being appended to the minutes.

A letter from Mrs. Karl Blanchard expressing her thanks to the Association for the resolution of respect for Karl was read and filed.

The ecretary asked the members for their essistance in an effort to keep the list of property owners current. It was decided to remind members when notices of next year's meeting are sent that dues are \$1.00 per year.

Fir. wickes distributed copies of the current law regarding water skiing and surfboarding. The Secretary has additional copies for members not present who may wish to have them.

Mr. Tobin reported that the State Water Resources Commission is still working on a pamphlet on water pollution and is expected to have it ready in six months. He believes that, after publication, there will be random inspection and sampling, as well as regulations for new construction.

Fir. Tobin reported that Mr. Stubing has been granted a permit to place fill in the lake in accordance with the revised plan submitted the day of the hearing. The drawings and description give explicit specifications. The work will be checked as it proceeds by the Water Resources Commission and the Conservation Department.

br. Tobin thanked the members of the association for their cooperation in this matter, and especially for their letters to the later Resources Commission. These letters were a part of the public hearing.

closely as possible with Mr. Stubing. Since it was deemed advisable to have an attorney, Mr. John Lawson of Lawson and Lawson was engaged. The Association will receive a bill which will not exceed \$100. It was moved by Mr. LePeve and seconded by Mr. Muchleck that the bill for Mr. Lawson's fee, up to \$100, be paid upon presentation.

A motion was made, seconded, and unanimously carried that we contribute \$25.00 to the Chilson Fire Dept.

The future location of the Association's pumper was discussed. Possible locations, such as Phillips's and Stone's camps, were suggested. Mr. Wickes and Mr. Tobin will explore these possibilities.

Mr. Runge wondered if anything could be done at the dam site to effect a lower water level in the lake which is now reported to be 4 inches 1870 normal high water. Mr. Tobin volunteered to check the dam, stating that it is supposedly a "natural" dam and the Association has avoided having the Conservation Department become involved.

Since the current officers declined renomination due to various personal circumstances, the following slate of officers was nominated:

It was moved by Mr. LeVeve, seconded by Mr. Wickes, and unanimously carried that the secretary cast one ballot for this slate of officers. A hearty vote of thanks was given to the current officers, with special note that Mr. Martin had served as Treasurer since 1958.

The next annual meeting will be held at Crown Point Beach Saturday, August 8, 1970 at 2:30 P. M. Meeting adjourned.
