The meeting was called to order by Chairman Roger Wickes, and the following items were discussed: --

- 1) The Pilot Project for Milfoil Control
- a) Senator Stafford's office awarded \$35,000 to the Lake George/Eagle Lake Pilot Project and approximately \$10,000 has been used for required pre-treatment work.
- been used for required pre-treatment work.

 b) A Dept. of State Grant was awarded to Eagle Lake for \$7500.
- c) An application for \$5000 has been submitted for a Rural NYS Environmental Action Grant--status to be determined in the fall.
- d) The status of further state funding is uncertain because of the state budgetary process.
- e) Suggestions were made about investigating other options for financing the project and addressing members' concerns.
- f) The Board expressed interest in continuing as a part of the DEC Pilot Project.
- g) A motion was made and seconded to authorize Lloyd Burroughs and Wendy Davis to continue to pursue any grants that become available. Passed unanimously.
- h) The AdHoc Committee on Milfoil was reappointed consisting of Bill Allen, Lloyd Burroughs, Wendy Davis, Bill Knauss and Diane Tiedemann
- 2) Bill Knauss and Bill Allen attended the meeting of the Rte. 74 Assn.
 - a) Their name has been changed to the Paradox Lake Assn.
- b) A permanent committee on Rte 74 will be established with two members each from Paradox and Eagle Lakes. It was suggested that Ruth Cummings be one of our representatives.
- 3) Problems have arisen at Crown Point Beach: --
- a) Inappropriate behavior has been noted; rowdiness, excessive drinking, garbage, dogs unleashed, etc.
 - b) Suggestions to resolve these problems-
 - i) Contact ranger to investigate
 - ii) Call State Police and include car licenses of offenders if possible
 - iii) Jim Davis will contact Ranger Bob Morris about putting more informational signs on the beach
 - iv) Roger Wickes suggested sending a letter to DEC informing them of the problem
 - v) John DiPofi will call Raybrook for further info

- 4) Bill Knauss asked if dues are tax deductible; Roger Wickes will check on this.
- 5) John DiPofi, announced that he has the new beaver permit, valid until 10/15/97, adn that Mr. Hebert has a copy. John will check with Pete Buechner about our procedures for reimbursing Mr. Hebert for the beavers which he traps.
- 6) The lake level was +1 as of 8/9/97. Fay Spring had previously expressed concerns about water level; a suggestion was made that he be considered for the Water Level Comm.
- 7) Wendy Davis has resigned as chairman of the Education Committee and a new chairman must be appointed.
- 8) Jim Davis reported on the voluntary project to check sewer systems in conjunction with the town. Volunteer hours can be used to offset matching funds.
