## Eagle Lake Adopt-A-Highway Spring Clean-Up Completed!

As she always does, Tonya will continue to do small pickups throughout the summer as needed, and she would love to enlist our help in doing so – just picking up in front of our own properties will help greatly. ## Annual Meeting & Picnic July 5, 2014

The board hopes that all members will make a special effort to participate in this year's membership meeting, with several issues of importance to all of us on the agenda. And be sure to use the mail-in form at the back of this issue to renew your membership and reserve your spots at the picnic!

### **BEFORE the July 5th Annual Meeting – PLEASE VOTE on the Proposal to Reduce the Board From 9 Members to 7**

When you send in your membership renewal and dues this year (see the form included in this newsletter), your board of directors is asking that you vote YES or No on reducing the size of the board.

The current ELPOI Board of Directors has nine members – four officers and five directors. The board is recommending that the membership reduce this number to seven – four officers and three directors. The change requires a vote of the membership, as encoded in our by-laws, and would be accomplished simply by not filling the next two vacancies that come up as current member's three-year terms expire. If our members approve it, the change will take place beginning immediately, as provided for in the ELPOI by-laws. (And, of course, the membership can always vote to reverse the change at any point in the future if they feel that circumstances warrant it.)

A major reason for this proposal is the declining pool of members willing to serve on the board, but the move will have other benefits, including especially making it easier for a quorum of the board to meet to make operational decisions and conduct day-to-day business. (Seven members, incidentally, was the original size of the board when ELPOI was formed back in 1907.)

You can vote on this recommendation by voting YES or NO on the question in the enclosed membership renewal form, and sending it back as soon as possible but (please!) no later than June 15th. Remember, you must be a paid member to vote!

## Treasurer Needed!

Because of the press of other responsibilities, Jeff Becker resigned from the position of ELPOI treasurer in February; board member Rolf Tiedemann has accepted the responsibilities of interim treasurer until a permanent treasurer is elected. If you would be willing to serve, please let Chris Hyde know by e-mail at [cdhyde1@gmail.com](mailto:cdhyde1@gmail.com) so that your name can be added to the ballot at the July 5th annual meeting. Please accept the board's apologies for a few resultant delays in check deposits and erroneous notifications that some memberships were not current.

## The Eagle Lake Milfoil Project

With a little over \$34,300 remaining in our milfoil abatement account with the Town of Crown Point, members decided at our last annual meeting not to pursue either of the high-cost options open to us (the possible limited-area use of Renovate™ with curtains, or contracting for lake-wide hand harvesting). However, milfoil project leader Rolf Tiedemann has continued to gather the information and marshal the support that we will need to make decisions about the milfoil battle this year. On the board's behalf, Rolf, Dianne and Chris have jointly written a letter to Governor Cuomo and a detailed response to the park agency's call for public comment on Renovate™ use, and are now gathering data for submission of a modified Renovate™ proposal to the A.P.A. for treatment of Ticonderoga Bay and the waters around the public beach. Rolf has become recognized and respected for his expertise in milfoil control in the North Country, and through his advocacy and lobbying leadership, ELPOI may eventually succeed in getting the A.P.A. to modify its prohibitive stance. Much more detail about the milfoil project, including copies of correspondence, is available on the web site, and the milfoil project will be a major topic of discussion at the July 5th annual meeting.

## CLEAN-DRAIN-DRY



CLEAN-DRAIN-DRY guidelines for residents and visitors will help protect Eagle Lake and stop the spread of invasive species...

### *After boating, before you leave the launch...*

**CLEAN** – Remove all visible plants, animals, fish, and mud from your boat, trailer, or other equipment and dispose of in a suitable trash container or on dry land.

**DRAIN** – Drain water from bilge, live wells, ballast tanks, and any other locations with water before leaving the launch.

### *Before you arrive at the launch to go boating...*

**DRY** – Dry your boat, trailer, and all equipment completely. Drying times vary depending on the weather and the type of material. At least five days of drying time is generally recommended during the summer.

Remember that these rules apply to water sports equipment, kids' toys, and even clothing. And the car wash in Ti is a good place to give your boat and trailer a good cleaning. Rolf has asked DEC to post CLEAN – DRAIN- DRY signage at the boat launch, too.

## No Need for Speed



Board Member Mary Loose reports that on Labor Day weekend last year two boats were racing around the bend and were so close to the shore that they almost hit the Loose's swimming float. If there had been swimmers in the water the boats could not have avoided hitting them. This kind of thing is happening more frequently on Eagle Lake, and it's time for all of us to start speaking up. In New York State, vessel speed is generally limited to 5 M.P.H. when within 100 feet of the shore, a dock, pier, raft, float, or anchored boat. When no speed limit is posted, vessels must always be operated in such a fashion so as not to endanger others. A vessel must be able to stop safely within the clear space ahead. A vessel operator is always responsible for any damage caused by the vessel's wake. Make sure that your family, friends and visitors know the rules, and follow them. If you see dangerous boating behavior on the lake, try to intervene in a friendly, non-confrontational way if you can do so safely; if you can't, call dispatch at NY State Department of Environmental Conservation: (518) 891 0235 to report what you witnessed. DEC officers will need a good description, including boat names and registration numbers. For more information about boating safety, get the guide at...

## Truck Rollover Warning Signs Installed



## Ticonderoga Water Project

Under newly elected Supervisor Bill Grinnell, the Ticonderoga Town Board has decided on a new plan for the town's water supply, which is under state mandate to be improved by 2016. Gooseneck Pond and Lake George are to remain the primary water sources, supplemented by the recently completed well on Streetroad. The controversial original plan would have eliminated use of Gooseneck Pond, problematic for Eagle Lake and Chilson residents who depend on that supply. For more information, see...

The Citizens Statewide Lake Assessment Program (CSLAP) is a volunteer lake monitoring and education program managed by DEC and the New York State Federation of Lake Associations. Information from a variety of sources is combined to create a scorecard for each CSLAP lake. CSLAP sampling on Eagle Lake has been done for many years by Paul and Lloyd Burroughs, to whom we owe an enormous debt of gratitude; this year as last the Tiedemanns and the Hydies will be pitching in to help. Volunteers like Rin Fraize have also contributed to water-testing efforts, including the annual fecal-coliform analysis which will continue this year. In other lake management news, Board Member Jack Mulcahy and his family, with help from Chris Hyde and Rolf Tiedemann, have been managing the lake level by adding and removing boards as needed from the dam throughout the past year. And finally, Peter Popinchalk reports that earlier in the spring he visited the fish hatchery in Crown Point, where he learned that that this year's stocking would consist of one dump of 400 12" brown trout. And Tonya Condon confirmed via Facebook that the trout indeed arrived on May 21.

### **New Ticonderoga Supervisor Elected, Expresses Continuing Support of Eagle Lake**

Last November's elections brought about a change in Ticonderoga town leadership; the new supervisor is Bill Grinnell, who replaces Deb Malaney. Rolf and Dianne Tiedemann had an opportunity to meet with Mr. Grinnell in February, and report that the new official is a fisherman who knows our lake and its condition well, and is interested in working with us to preserve it. The Tiedemanns briefed him on our long history of interactions with the Adirondack Park Agency and on current hopes for milfoil control in the lake.

### **"Adirondack Lawn" Campaign around Lake George**

In a new campaign that some Eagle Lake residents want to emulate, small signs on properties around Lake George this year proclaim, "Adirondack Lawn GROWS HERE." Water quality activists define an "Adirondack Lawn" as a property that does not use harmful chemicals and adheres to good stewardship practices; they are advocating for towns within the Lake George watershed to adopt a common Lake George Fertilizer Restriction Law. "Fertilizers not only feed the lawn, but also feed unwanted algae and invasive aquatic plants in the lake. To avoid the need to use fertilizers, mow your lawn to a minimum of 3 inches, leave the grass clipping on the lawn to provide nitrogen (in lieu of adding fertilizer), and periodically aerate the soils to encourage healthier growth. Replace expansive lawns with native trees, shrubs and perennials to add root depth and increase infiltration and treatment of stormwater," said Kathy Bozony, Lake George scientist, diver and activist. 

## ELPOI Offers Glassware and T-Shirts Sales as Fund Raiser


