The Milfoil Project: Progress Report

Is "no news" really "good news"? Well, in this case it may be. Last summer milfoil growth was significantly down in many areas of the lake and we are happy to report minimal growth so far this year. While the fight is not over we are taking a pause because of our continued dialog with the APA, DEC and the recent memorandum of understanding (MOU) that was signed onto by ELPOI in April, the fight against invasives is evolving yet again. "The purpose of this (MOU) is to describe an understanding among the diverse undersigned organizations representing state agencies, municipal governments, property owners, lake associations, conservation groups, and businesses regarding a program to prevent the introduction and spread of aquatic invasive species in the Adirondack region." Unfortunately, though, as was reported last fall in an e-mail to members, Curly Leaf Pondweed was found in the lake. It's yet another invasive, and may have come from a nearby lake. DEC and APA rapid-response staff are hoping that Clean – Drain – Dry (see below) will help; Rolf is working on further assessment of the problem in Eagle Lake.

In addition, Keith Park has agreed to stand for secretary, filling the position vacated by Mary Loose. The board will propose an extension of Lloyd's term, as well as Keith's confirmation, for full-membership vote at the annual meeting. Thanks go to Jack Mulcahy for keeping an eye on our dam and renewing our DEC beaver-removal permit for 2015. As usual we are battling with the beavers – and right now they're winning. The lake level continues to rise, and with recent rains something needs to be done soon. The lake level is our collective responsibility, and we can't expect Jack to do it all by himself! In that spirit, several members banded together to give the beach an early spring cleaning: leaves raked, brush and branches picked up, etc. Thanks to all who took part! Remember that when you use the beach it is a carry-in, carry-out location, and overnight camping there is restricted to the designated camping area and is monitored by the NYS DEC.

Warren County: A Model Aquatic Transport Law



Seven towns and villages in the Adirondacks, in addition to Warren County, have local transport laws, and Warren County has offered its law to other counties as a model for their own efforts. Here's hoping the idea catches on.

CLEAN–DRAIN–DRY

CLEAN–DRAIN–DRY guidelines for residents and visitors will help protect Eagle Lake and stop the spread of invasive species...

After boating, before you leave the launch...

CLEAN – Remove all visible plants, animals, fish, and mud from your boat, trailer, or other equipment and dispose of in a suitable trash container or on dry land.

DRAIN – Drain water from bilge, live wells, ballast tanks, and any other locations with water before leaving the launch.

Before you arrive at the launch to go boating...

DRY – Dry your boat, trailer, and all equipment completely. Drying times vary depending on the weather and the type of material. At least five days of drying time is generally recommended during the summer.

Remember that these rules apply to water sports equipment, kids' toys, and even clothing. And the car wash in Ti is a good place to give your boat and trailer a good cleaning. Rolf has asked DEC to post CLEAN – DRAIN- DRY signage at the boat launch, too.

Boating Rules:

All mechanically powered boats must be currently registered in New York or in another state. A valid registration card must be carried on the boat at all times.

Speed is limited to 5 miles per hour within 100 feet of shore, dock, raft, moored boat or anchored boat (notably fisherman). All inland bodies of water in New York have a maximum 45 mph. speed limit. Any vessel towing a water skier, wake board or tube, must have on board, in the addition to the operator, an observer at least 10 years of age who will watch out for the person being towed. All towing activities are restricted to the hours between sunrise and sunset.

All boats must have the following safety equipment:

NEW Cold water PFD rule: Starting Nov. 1, kayakers, canoeists and those aboard all other boats under 21 feet, must wear Coast Guard-approved personal flotation devices while on New York's coastal waters, lakes, rivers and other waterways. The rule will remain in effect through May 1. Violators face fines ranging from \$25 to \$100.

1. All boats including canoes, kayaks and row boats must have ONE Personal Flotation Device PFD (life jacket) PER PERSON in the boat. It must be worn by children under 12 years old while the boat is underway. The life jacket must be Type I, II or III as rated by the Coast Guard. A throw cushion does not count as a PFD.

2. One Type IV throw able cushion or life ring.

3. Motor boats over 16' in length must have visual distress signals. This can be satisfied by having day/night flares or an "SOS" flag for day use and a battery operated distress light for night use. It is noted that flares will cover the requirement but may not work if they are wet or expired. Be sure to check the dates stamped on flares. Most are only good for three years

4. Fire extinguishers are required on closed cabin boats and inboard or Inboard/Outboard boats under 26' long. Outboard powered boats of open construction under 26' are not required to carry a fire extinguisher.

5. All motor boats are required to carry an anchor and line of sufficient weight to provide safe anchorage.

6. All motor boats must have a working whistle or horn.

7. Navigation and Anchor lights must be displayed between the hours of sunset and sunrise.

Other Suggested Equipment:

Oar /Paddle, Bilge pump/ bailing bucket, First Aid kit, Boat hook, Tool kit / Spare parts, Fire Extinguisher

Jet Ski / PWC Rules:

New York State requires that everyone operating a personal watercraft (PWC) complete an approved course in boating safety or are otherwise accompanied, on board, by someone 18 years of age or older who is the holder of an approved boating safety certificate. Operator must be at least 14 years of age to use a PWC without another adult over the age of 18 who has a boating safety certificate. Certificates are required to be carried at all times when operating the PWC. All PWCs must be currently registered in New York or another state. Valid registration must be carried on the PWC at all times.

Speed is limited to 5 miles per hour within 100 feet of shore, dock, raft, moored boat or anchored boat (notably fisherman) All inland bodies of water in New York have a 45 mph. speed limit.

Operators, passengers and any person being towed behind a PWC must wear a Coast Guard approved personal floatation device (PFD)

Engine Cutoff - Must be functional and attached to rider

Horn / Whistle - Capable of a 2-second blast, audible for 1/2 mile

Visual Distress Flag- Must be at least 1 square foot - Fluorescent Orange

Any vessel towing a water skier, wake board or tube, must have on board, in the addition to the operator, an observer at least 10 years of age who will watch out for the person being towed. The Skier is considered a passenger and is to be counted against the maximum passenger capacity. In order to tow someone behind a jet ski it must be rated for three people: driver, observer and skier.

Operation of a PWCs and waterskiing / tubing is restricted to the hours between sunrise and sunset. Adding lights to a PWC will not allow it to be legally used at night.

Since PWCs cannot immediately stop, it is important to stay clear of other boats and swimmers.

Operators of jet skis and all other power boats should be mindful of property owners and environmentally sensitive areas. See NYS Boaters Guide or go to www.nysparks.com for more information.

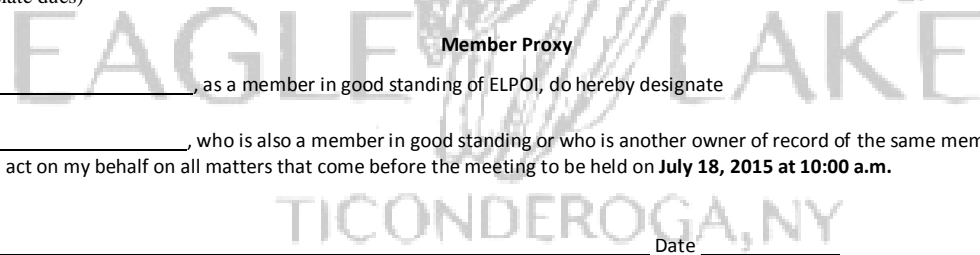

Mission Statement

Whereas the property owners on Eagle Lake, Essex County, New York, organized themselves, their associates and their successors into an Association on September 13, 1907 for the purposes and objects set forth below,

First, for the protection of the mutual interest and property of the members. Second, for the re-stocking of Eagle Lake from hatcheries. Third, for the regulation and control of a uniform water level in Eagle Lake. Fourth, for the prevention of the pollution of the water in Eagle Lake. Fifth, for the protection of spawning beds in Eagle Lake. Sixth, and for such other objects and purposes as may from time to time be determined upon by the members of the organization for protecting the mutual interests and property of the members.
