

MINUTES OF THE FOURTEENTH ANNUAL MEETING OF THE
EAGLE (CHILSON) LAKE PROPERTY OWNERS' ASSOCIATION
HELD AT "FONET" LODGE, EAGLE LAKE, ESSEY CO., N.Y. ON FRIDAY, AUG. 5, 1921.

In the discussions under the head of New Business the members individually & unanimously approved the re-establishment of the summer office at Eagle Lake and considered it advantages.

There being no further business, on motion duly made & carried, the meeting then adjourned.
