MINUTES OF THE SEVENTEENTH ANNUAL MEETING OF THE  
EAGLE LAKE PROPERTY OWNERS' ASSOCIATION  
HELD AT "EDNET" LODGE, EAGLE LAKE, ESSEX CO. N.Y. ON AUG 29 1924

The seventeenth annual meeting of the Eagle Lake Property Owners' Assn. held on Saturday Aug 29<sup>th</sup> 1924 at "Ednet" Lodge, Eagle Lake, Essex Co. N.Y. was called to order by Mr. F.B. Wicks, as Pres. pro tem. in the absence of the Pres. & V.
