Starting next spring, adjustments will be made to contain enough water to carry through the summer dry spell, so that the lake level does not

go as low as we have experienced this year. In the fall, after the boating season is over, the level will be lowered to prevent ice damage to docks and boat houses.

Route 74 Speed Limit Committee - Joe Zepf, Chairman
