Previous Request and 2019 We received a \$700 grant from IP for our ongoing Donation Summary environmental water quality program. Results of our efforts continue to be favorable, as indicated in the 2019 CSLAP water assessment. Quotes from that report can be found below:

> Eagle Lake continues to be oligotrophic, or unproductive, based on moderate water clarity, low algae levels (chlorophyll a), and low nutrient (phosphorus) levels.

#### International Paper

Soluble nutrients were analyzed again 2019.

Most of the nitrogen in the lake is soluble, indicating a potential for more algae growth.

The lake has

near neutral pH, intermediate hardness water, low water color, and low nitrogen levels.

Compared to other nearby lakes, Eagle Lake usually has higher water clarity.

Since 2000, deep phosphorus and conductivity have increased slightly, and water quality survey assessments have improved slightly.

\* Proposal Summary This grant application seeks funding to help support ELPOI's testing of environmental water quality. ELPOI continues to support the public outreach for education of lake issues and our ongoing efforts to monitor, maintain and document the water quality of Eagle Lake, which is located in the Towns of Ticonderoga and Crown Point NY.

\* Proposal Detail The proposal is a request to assist ELPOI in covering the costs associated with the continued testing and monitoring of Eagle Lake waters in conjunction with NYS CSLAP (Citizen State Lake Assessment Program) and NYS FOLA (Federation of Lakes). This is a volunteer program, in which residents and members of ELPOI collect water samples over a 12 week period for testing, analysis and reporting performed at NYS DEC facilities. In addition to NYS CSLAP and NYS FOLA testing, ELPOI performs supplemental testing for Fecal and chemical analysis through the Darrin Freshwater Institute.

In addition to water testing, ELPOI maintains signage at both the boat launch and campground to communicate the importance of NYS DEC and APA's message of 'Clean, Drain, Dry," which is a program to prevent the spread of invasive species which can contaminate water and affect water quality.

Both current and past water quality documentation is posted to our website where comparison can be made to the health of the lake. Additionally, lake monitoring and water quality is communicated regularly to the members of ELPOI via our newsletters.

\* Expected Outcomes Water testing performed under NYS CSLAP and NYS FOLA as well as Fecal and chemical analysis will provide a snapshot of the health and environmental quality of the water in Eagle Lake.

Results will be communicated to ELPOI membership and available for the public to view via our website.

\* Evaluation Current and past data from our water testing is reviewed by our board and posted to the ELPOI website. This is done in

	conjunction with the historical review and comparison performed with the data received from the DEC CSLAP data and provides ELPOI with a yearly report that can be used to determine the health of the lake. ELPOI has a yearly meeting to discuss issues facing the lake. During this time the health of the lake is discussed including feedback from lake residents.
