# **Boat Launch Update**

The attorneys retained by ELPOI recently met with attorneys from DEC and APA. The DEC/APA attorneys said their principals firmly believe the only way to meet the requirements of the State Land Master Plan (SLMP) is to barricade the launch. This is in spite of the paragraph in the SLMP stating that pre-existing launches could, subject to periodic review, be kept open. Our attorneys offered various compromise solutions, such as a week in the spring and fall that the launch would be open to residents. DEC/APA attorneys did not think our solutions met with the SLMP.

Our attorneys, therefore, will begin to prepare legal papers to file action against the state, Article 78.

What is Article 78? A lawsuit mainly used to challenge an action (or inaction) by agencies of New York State and local governments. In our case, there would be an inaction to complete the carrying capacity studies of the lake.

#### October 14, 2024

This is the date the launch is scheduled to be barricaded. If you need to use the launch this fall, you need to remember this date.
