The action involves the treatment of up to 190 + acres (defined areas) of Cazenovia Lake through the application of the herbicide "ProcellaCOR EC". The treatment is designed to address the increased presence and proliferation of the invasive aquatic plant Eurasian watermilfoil (*Myriophyllum spicatum*) which had dominated the aquatic plant community in recent years. This action represents a seventh phase of treatment (2021 treatment) and will complement previous treatments of affected areas of the Lake. The project is located in Cazenovia Lake, 1,164 + surface acres, in the Town of Cazenovia, New York.
