A clarification about Lake Luzerne's "Benthic Matting" cost – we are spending \$12-\$15M per year *to mat 1.5 to 2 acres*. And this does not get us ahead of the spread. This cost does not include volunteer time, which, if costed at \$15/hr, would add about \$5M more. Compare this cost – about \$10M per acre to kill the entire benthos, to \$1M per acre with triclopyr to kill only dicot plants. No brainer?
